DECISION

Based on Article 24 in relation to Article 315 item 3 and based on Article 52 of the Act of 30th June, 2000 - Industrial Property Rights (consolidated text: Journal of Laws of 2017, item 776) the Polish Patent Office after examining the application number P.414791 of 15th November, 2015, hereby grants to:

KLEJDYSZ ROBERT, Wołów, Poland

PATENT

for the following invention:

Cryogenic chamber for horses

under the condition of paying a fee of PLN 480 for the first period of protection of the invention beginning on 15th November, 2015 and covering 1-3 years of protection *). -/-

Legal basis: Article 224 item 1 of the Act on Industrial Property Rights and point II subpoint 1 of the schedule of fees constituting Annex 1 to the Regulation of the Council of Ministers of 8th September, 2016 amending the regulation on fees related to the protection of inventions, utility models, industrial designs, trademarks, geographical indications and topographies of integrated circuits (Journal of Laws of 2001, No. 90, item 1000, of 2004 No. 35, item 309, of 2008 No. 41, item 241 and of 2016 item 1623). -/-

The Polish Patent Office calls for payment of the fee within three months from the date of service of the decision. -/-

If the indicated fee is not paid within the prescribed period, the Polish Patent Office, pursuant to Article 52 item 2 of the Act on Industrial Property Rights, shall declare the expiry of the decision to grant the patent. -/-

The party is entitled to a request for reconsideration of the case by the Polish Patent Office within two months from the day of its service. The fee for the application for reconsideration is PLN 100 and shall be paid into the Office account. If the party does not want to exercise the right to file a request for reconsideration, they may submit a complaint via the Office to the Province Administrative Court in Warsaw within 30 days from the date of service of the decision to the party. The fee for the complaint is PLN 1,000 and shall be paid into the court account. A party may apply on the basis of the provisions of the Act on proceedings before administrative courts for exemption from court costs or for granting the right to legal assistance. -/-

Based on Article 227 of the Act on Industrial Property Rights and point 1 subpoint 12 of the list of fees, the Polish Patent Office calls for payment within three months the sum of PLN 90 for the publication of the patent. -/-
